





## Technical Visit "Food Waste Recycling Pilot Plant and Unmanned Surface Vehicle (USV) at Zhuhai, Mainland China"

# The technical visit will be jointly organized by CIWEM HK, EAHK Chapter, HKIQEP and ETS Centre of HKPC

#### **Programme Highlights:**

A) **Food Waste Recycling Pilot Plant**: This food waste recycling pilot plant (1 tonne/day) was jointly set up by the Environmental Technology and Solution Centre (ETS Centre) of Hong Kong Productivity Council (HKPC) and Associated Engineers Limited (AEL) in Zhuhai in 2018 to demonstrate the innovative "3-step Zero Effluent Discharge Food Waste Total Recycling Process" developed by HKPC to convert food waste into high market values products including biogas and protein-rich animal feed. This patented technology has got a number of local and international awards, including Gold Medal with Congratulations of the Jury in the 45th Geneva International Exhibition of Inventions 2017 and the Innovation Award at the 2017 Institution of Engineering and Technology in London.

B) Unmanned Surface Vehicle (USV) is a professional robot working on the water surface. It has demonstrated more and more benefits to various environmental application areas, such as water sampling, water quality monitoring, water surface cleaning, and nuclear radiation monitoring etc. YunZhou is the world-leading USV solution provider.
